At the 20th January 2018 Community Workshop you saw a presentation of the December version of the Concept Framework for the Gilston Area, highlighting the changes and improvements since the September 2017 workshop. You then had the opportunity to review the December version and comment further on its content. Both East Herts District Council (EHDC) and Places for People (PfP) attended this workshop and heard first hand your thoughts and any remaining concerns you have with the December version of the Concept Framework. All comments were recorded by our consultants, Urban Silence.

See Gilston Community Workshop 23-01-2018_Comments Log at HEGNP.org.uk hilst the revised Draft Concept Framework (December 2017) has addressed many of the concerns raised by the community, it still leaves many grey areas that require further clarification and points that should be addressed before the Concept Framework (CDF) is finalised. A document; tabling the comments made at the two workshops, what action the Neighbourhood Planning Group wish to happen along with "traffic light" comments showing, for example, where the community concerns have been successfully addressed by the Dec 2017 version, where the concerns previously expressed have not been addressed, etc.; is being maintained.

We have just met with EHDC and PfP to discuss these documents and what changes to the December 2017 Concept Framework we are still seeking, we will send you a further update of the outcome of this meeting as soon as possible.
